I. CALL TO ORDER

The meeting was called to order at 9:32 am by Chairperson Carie Johnstone.

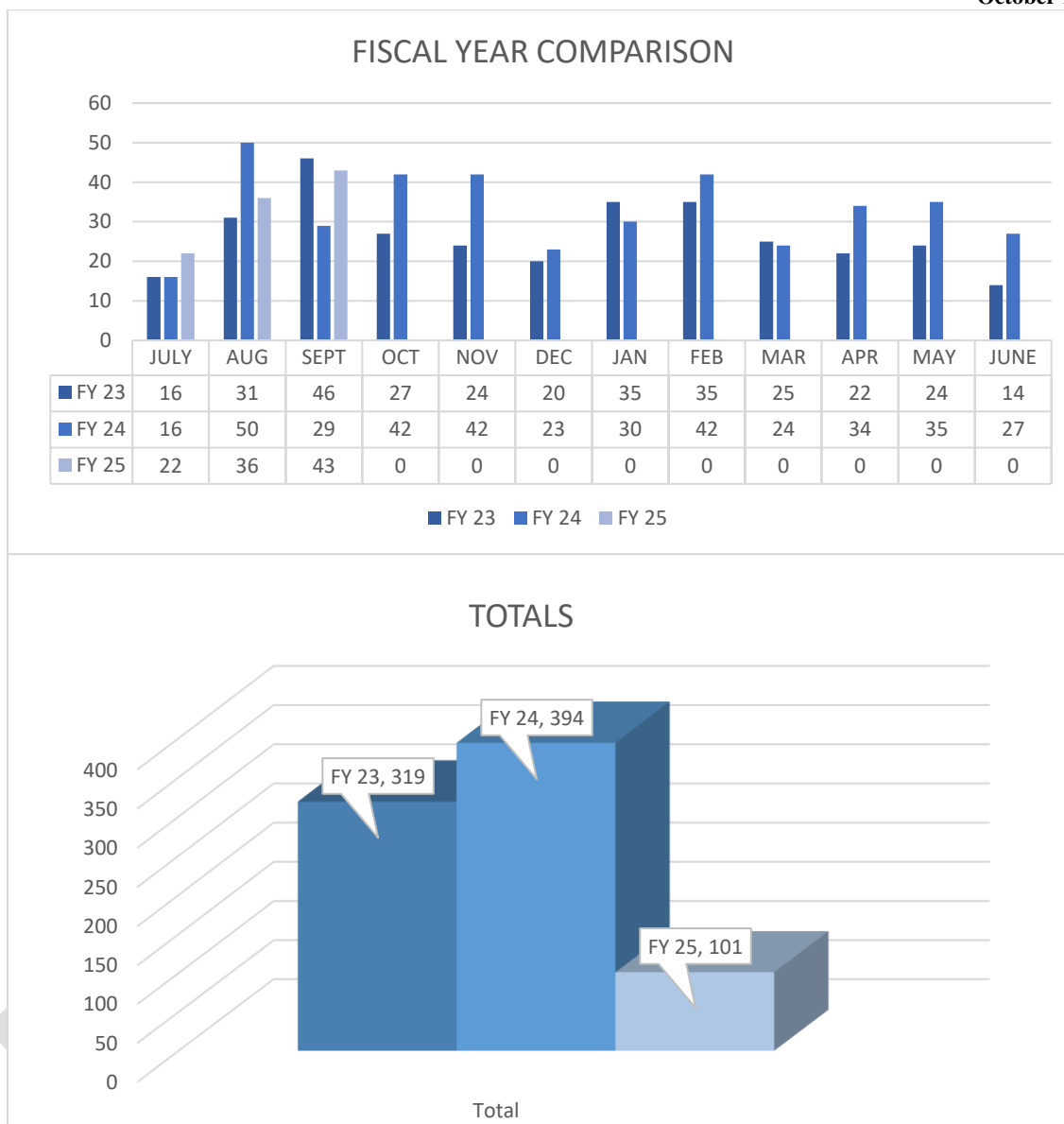
CBHTI Update:

The new BEACON portal launched in August. CRSA staff participated in several trainings and continue to participate in the weekly interagency crisis calls. Currently, CRSA staff are working collaboratively as assigned "parent navigators" on 17 cases within the BEACON portal.

CRSA Progress:

CRSA staff have started FY 25 with a bang! They have been busy attending IEP meetings, serving as parent navigators, conducting presentations, and increasing their community outreach efforts. We are preparing to exhibit and attend the Illinois Statewide Transition conference on 11/7-11/8/24 in Springfield. I continue to participate in weekly CBHTI Interagency Crisis Staffing calls, monthly Mental Health Summit, Southland Transitional Planning, Special Education Advisory Committee to the Attorney General, and quarterly Public Education Subcommittee meetings.

CRSA staff have continued to maintain a presence in the community. During August and September, staff participated in (43) IEP meetings, (21) family meetings, conducted (6) presentations, attended (68) other meetings and conferences, and led (16) outreach efforts.

VIII. AGENCY REPORTS

Illinois State Board of Education: Amanda Clay reported: ISBE Special Education is entering a very busy season with presentations planned at numerous conferences including IAASE in Tinley Park in October and Proficio in Oak Lawn in November. Additionally, we've been heavily involved in the communications surrounding the BEACON portal Phase 2 roll out which will include special education administrators, school social workers, and school counselors. We will be hosting two webinars previewing the care portal to this limited audience on October 31 & November 1

Illinois Health Care and Family Services: Dustin Knollenberg reported: Since posting a Notice of Funding Opportunity for providers who wished to establish new Community Mental Health Centers, Behavioral Health Clinics, and/or begin providing Pathways to Success and other community-based services in February this year and receiving over 70 applications from interested providers, we now have 19 CCBHCs established and proving services in Illinois.

In addition, Pathways to Success continues to add new youths to the program each month as well. We have referred nearly 3000 youth over the past 9 months, and about 70% are currently active within the program.

In September, HFS staff attended the AOIC event in Chicago and were part of the training and conversation revolving around rethinking the intersection of competency to stand trial, competency restoration, and mental health systems for both children and adults. We spoke with

Illinois judges, state representatives, public defenders, law enforcement, IDOC and IDJJ staff, as well as staff from Cook County jail and other county detention centers to have meaningful conversations about putting mental health services other resources in place for individuals while incarcerated or paroling and reentering back into the community in order to reduce recidivism.

HFS continues to collaborate closely with the Children's Behavioral Health Transformation Initiative and continues to participate in the interagency team Staffings, where we staff cases on a weekly basis, and work on a daily basis to help identify resources for these portal youth.

HFS is currently working with the team to help establish a capacity reporting tool that will allow us to identify the number of beds available in real time across all state agencies that may accept youth entered into the BEACON portal.
